SUBJECT: Change of Outpatient Imaging Service Authorization Procedures

Change of Service Authorization Reviewer

Effective April 15, 2013, providers will no longer submit outpatient imaging authorization requests to Xerox. Instead, requests will be processed by Qualis Health.

Change of Service Authorization Request Procedures/Web-Based Requirement

Providers will be required to submit all outpatient imaging authorization requests to Qualis Health via the web-based review system, iEXCHANGE®.

Qualis Health currently provides utilization management review services for the Alaska Division of Healthcare Services. Utilization management includes service authorization reviews performed for all inpatient acute care stays exceeding 3 days, for selected inpatient and outpatient procedures and diagnoses, regardless of length of stay, and effective April 15, 2013 for the following outpatient imaging services:

- magnetic resonance imaging (MRI)
- positron emission tomography (PET)
- magnetic resonance angiography (MRA)
- single-photon emission computed tomography (SPECT)
